Dear Planning Commissioners. The Shaw/Glenn project being discussed at your 9/7 meeting is something I have been following as it impacts adjacent Fresno County neighborhoods which I represent. The neighbors of Fig Garden and I have some concerns about this project and I will lay them out briefly. All of this was put in writing and previously sent to City of Fresno leadership including City Manager Tommy Esqueda and Fire Chief Kerri Donis in May of 2021 (attached).

Here are the issues. I, representing the County, asked Fresno City Fire to demonstrate that a fire on the interior side of this 5-story building can be successfully fought with parking lot constraints on large trucks. We have never had our questions responded to.

Also we have officially asked for an updated Traffic Study and were told one was not necessary. The City seems to maintain that there will be no new traffic impacts on narrow County streets in the adjacent neighborhood. This is ludicrous! We know there will be additional impacts with 128 new residential units plus commercial customers. This is connected to general concerns related to the density level of this project.

Until both of these concerns are addressed please know that Fresno County, representing the neighbors of this project, remain opposed to this project. In addition, the County may have to consider mitigating the impacts from your to protect our neighborhood from increased traffic.
