The design phase of the project was initiated in FY22 and preliminary engineering design and project management was completed over 10 months by City of Fresno staff. The scope of this project includes the construction of a Class IV separated bicycle facility along Barstow Avenue, between Blackstone Avenue and Cedar Avenue, through a partial slurry and a partial grind and overlay of the roadway that will eliminate existing lane markings and provide an improved driving and cycling surface, placement of new roadway striping and signage, installation of green methyl-methacrylate (MMA) to highlight areas of conflict between bicyclists and motor vehicles, and the installation of flexible delineator posts to create the separated and protected space that defines a Class IV facility.
