WHEREAS, on March 30, 2023, the Council of the City of Fresno adopted Council
Resolution No. 2023 calling a special mailed-ballot election on levying special
taxes on land within, and on approving an annual appropriations limit for Annexation No.
LS003 to Community Facilities District No. 17 (CFD No. 17); and

1. The Council finds and declares that: (a) the ballot measure on the levy of

was submitted to the qualified electors within the area of Annexation No. LS003, pursuant
to Council Resolution No. 2023, and (b) the ballot measure has been passed and
approved by more than two-thirds of the votes cast, in accordance with the City of Fresno
Special Tax Financing Law, Chapter 8, Division 1, Article 3 of the Fresno Municipal Code
("City Law").

The Council declares Annexation No. LS003, to be fully formed and the property within Annexation No. LS003, to be subject to the levy of the special taxes, the special tax lien, and appropriations limit described in Council Resolution No. 2023-______, annexing Final Tract Map No.6299 as Annexation No. LS003, Authorizing the Levy of a Special Tax Therein, and approving local goals and policies for Community Facilities (Service) Districts; and described in the Community Facilities District Report dated as of February 23, 2023, on file with the City Clerk.

3. The Council directs the City Clerk or designee to record a notice of special tax lien in the Office of the County Recorder, pursuant to City Law, no later than 15 days after this resolution is adopted.
