SUBJECT:

REVIEW AND DETERMINATION, WORK PROPOSED FOR THE FRESNO WATER

TOWER SITE, HISTORIC RESOURCE #1

BACKGROUND

Attached are plans for restoration and new construction work proposed at the Fresno Water Tower site. As the Historic Preservation Commission (HPC) is aware, this ongoing project has been the subject of numerous meetings between the HPC subcommittee, the Convention and Visitor's Bureau (the tenant), the project engineer and city staff to ensure that the project does not negatively impact the Tower, while adapting the site to current tenant needs. The result thus far represents a compromise by all parties, with particular sensitivity toward maintaining what is arguably Fresno's most significant historic resource.

Exterior work includes a controlled pressure wash of the building, which will be monitored by Facilities Management to prevent damage. Wire brushing, sanding and/or scraping may be used to remove loose rust and paint from exterior metal--also to be monitored by Facilities Management. It is anticipated that the existing small holes in the Tower's metal cap will be sealed by primer, prior to the application of paint. Exterior paint colors were previously approved by the HPC.(A2.3) A bird deterrent system, "Bird-B-Gone," is proposed for installation at exterior railing, ledges, upper windows, roof and other nesting areas.(A2.4)

Site work such as rough grading, curb cuts, the extension of a retaining wall and the installation of a plumbing line from the street to the location of the proposed restroom building has been approved in advance of full HPC review.(A1.1, A1.2) Also approved by the subcommittee was the method used to abate the lead-based paint covering the first and second floor interior brick, and interior demolition work including the removal of the existing stairs, second floor and toilet.(A2.0)

Replacement of the front door is planned, as is removal of the rear exit door and surround, which are not original.(A2.6) Also proposed is a metal exit gate.(A2.4) Glazing in the entrance transom and porthole windows will be replaced where necessary. The stained glass window above the balcony will be repaired. Wood window frames will be repaired wherever possible. When historic fabric must be replaced, the HPC will be consulted prior to removal.(A2.4) New duct work is to be concealed in the tank.(A2.7)

Improvements include the construction of a small, Mission-style restroom building located to the south of the Tower. (Plans A2.2, A2.5) The restroom building will be constructed of materials similar to the Tower, in an effort to complement the Tower while minimizing visual impact. In addition, paving, landscaping and parking will be installed/upgraded.(A1.0-A1.6) A sign is to be located at the Fresno/"O" Streets corner.(A1.0) The engineer is seeking direction from the HPC regarding design of the sign.(S1.3)

Within the Tower, a mezzanine is planned. The mezzanine (13.5') and soffit (11') will be placed so as not to obscure the radiating brick arches topping the doorways.(A2.7) Stairs to the mezzanine will be a prefabricated unit with closed riser.(A2.1) The engineer is seeking direction from the HPC in terms of the handrail and baluster to be used. Display racks, counters, video screen, storage rooms, and doors will be installed as part of the Visitor's Center.(A2.1) The HPC has previously offered direction on the avoidance of incorporating elements in the Visitor's Center which may create a false sense of history.

Interior and exterior lighting is addressed.(E1, E2) Fixtures will be mounted in the passageway between the walls, and on the exterior deck. At this time the electrician is unsure how this lighting will be affixed to the building, and this work will be addressed at a future HPC meeting.

The HPC subcommittee has elected to refer items such as the security gate and installation of the exterior spike system to the entire Commission for its review. As previously stated, recommendations on interior railing and exterior signage are requested by the engineer. Improvements not yet finalized, such as what historic fabric may need to be replaced vs. repaired, and the installation of a new concrete floor for the Tower, will be addressed at a future meeting of the HPC.

ISSUE

Should the Historic Preservation Commission review and make a determination on the work thus far proposed for the Fresno Water Tower site?

CONCLUSIONS AND RECOMMENDATIONS

It is recommended that the Historic Preservation Commission review the project and those items now finalized, provide direction where requested, and determine if all proposed work is appropriate for the Fresno Water Tower site.

A. REVIEW AND DETERMINATION, WORK PROPOSED FOR THE FRESNO WATER TOWER SITE, HISTORIC RESOURCE #1 - DOLORES MELLON, DEPARTMENT OF HOUSING AND NEIGHBORHOOD REVITALIZATION
