I am writing because I received notification of the Planning Commission meeting on 9/7/22 and the opportunity to comment. I live at 148 W. Keats Avenue, Fresno 93704.

I am in favor of the project. I am aware that there is some opposition in my neighborhood and in the Old Fig neighborhood, apparently due to concerns about increased traffic. I believe this concern is unwarranted. The project is on Shaw, so any increase in traffic on the side streets off Shaw would likely be negligible.

Fresno has a homeless crisis and there is a shortage of affordable housing. This project would help alleviate that. Further a new building that includes housing, services and retail would be far better than having a vacant lot that is an eyesore.
