

FIRST AMENDMENT TO CONSULTANT SERVICES AGREEMENT

This First Amendment to the Consultant Service Agreement for professional security systems planning and design services for Fresno Yosemite International Airport and Fresno Chandler Executive Airport is made as of 3/25/2026, (Effective Date) by and between the City of Fresno, California, a Municipal Corporation (Fresno), and Deol Data, A Delaware Corporation (Consultant).

RECITALS

WHEREAS, Deol desires to perform, and City desires to have Deol perform, consulting services (Services) as an independent contractor to City at and for Fresno Yosemite International Airport (FAT) and Fresno Chandler Executive Airport (FCH); and

WHEREAS, City and Consultant entered into the Consultant Services Agreement for professional security systems planning and design services for the amount of \$834,400, which became effective March 11, 2024 (Agreement); and

WHEREAS, City desires to add additional funding to the agreement in the amount of \$817,000, to complete the integration, activation and commissioning of the new security system at FAT.

AGREEMENT

NOW THEREFORE, the Parties agree that the Agreement be amended as follows:

1. The recitals to this Amendment are incorporated and made a part of the Agreement.
2. Section 3(a), Compensation, shall be rewritten to read as follows:
 - (a) CONSULTANT'S sole compensation for satisfactory performance of all services required or rendered pursuant to this Agreement shall be a total fee of \$1,651,400 (One Million Six Hundred Fifty-One Thousand Four Hundred Dollars). Such fees include all expenses incurred by CONSULTANT in performance of the services.
3. All other terms and conditions of the Agreement shall remain in full force and effect. In the event of any conflict between the terms of the Agreement and the terms of this First Amendment, the terms of this First Amendment shall prevail.
