A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING AN EXCEPTION TO THE FORMAL BIDDING PROCEDURES AND AWARD A SOLE SOURCE AGREEMENT WITH SOLUTIONS BY DESIGN, INC., IN AN AMOUNT NOT TO EXCEED \$737,279.00 FOR THE VIDEO WALL DISPLAY AT CITY HALL AND REPLACEMENT OF THE COUNCIL CHAMBERS SCREEN

WHEREAS, the Information Services Department has identified a public work of

improvement project Video Wall Display at City Hall and replacement of the Council

Chambers screen, which requires work to be performed by Solutions by Design, Inc; and

WHEREAS, Solutions by Design, Inc. is the only provider of such utility services in

the City of Fresno, making the company a sole source for the necessary work; and

WHEREAS, Section 4-503(c) of the Fresno Municipal Code allows for an exception

to formal bidding procedures when the City Council determines that the work can only be

provided by one source; and

WHEREAS, the Information Services Department seeks to establish an agreement

with Solutions by Design, Inc. to provide the work in the amount of \$737,279.00 for the Video Wall.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

 The Council has received and considered the report and recommendations of City staff.

- 2. The Council finds it is proper for the City to dispense with the competitive bidding requirements and approve Solutions by Design, Inc. as the sole source vendor for the Video Wall Display at City Hall in an amount not to exceed \$737,279.00; and
- 3. This resolution shall be effective upon final approval.
