A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO RECLASSIFY THE TUPMAN PARK IMPROVEMENT PROJECT TO BE FUNDED WITH GENERAL FUND RATHER THAN COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS DUE TO DELAY CREATED BY REQUIREMENTS OF THE CDBG PROCESS

WHEREAS, the City of Fresno allocated \$225,655 in CDBG funding through its 2018-2019 Annual Action Plan for capital improvements to build and fence a neighborhood pocket park intended to serve predominantly low-and-moderate income persons, located at the corner of California Avenue and Tupman Avenue (Tupman Park, or Project); and

WHEREAS, due to CDBG program bidding requirements the City has incurred significant and excessive delays with the Project over the last two years; and

WHEREAS, to expedite the construction of the Tupman Park, the Council desires to reclassify the Project as non-CDBG and instead fund the park with General Fund revenue included in the Parks Department budget.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Staff is directed to coordinate with the City Attorney's Office to take all necessary steps to reclassify Tupman Park from a CDBG project to a General Fund project and reimburse CDBG funds for this Project, to the extent legally required.
2. Staff is further directed to immediately commence with the City's standard bidding process and complete the Project within 90 days.
