A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO CONDUCT A TRAFFIC ASSESSMENT TO INCLUDE OPTIONS FOR IMPROVED SAFETY FOR THE INTERSECTION OF VAN NESS AND CLINTON AVENUES

WHEREAS, safe, convenient, and accessible transportation for all users is an adopted priority of the City of Fresno; and

WHEREAS, crashes that result in death or serious injury are not inevitable but largely preventable and stem in part from human inattention and speeding; and

WHEREAS, it is the role of government to do its part to serve and protect and populace; and

WHEREAS, residents living within the intersection of Clinton and Van Ness Avenues in Central Fresno have been raising concerns regarding the intersection; and

WHEREAS, the City of Fresno is designated as a Pedestrian Safety Focus City by the Federal Highways Administration (FHWA); and

WHEREAS, the Council in partnership with the Administration desires to conduct a traffic assessment addressing the intersection and to develop recommendations to combat red-light problems, speeding, collisions with pedestrians and bicyclists, and any other issues identified during the assessment.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

 The City shall conduct a traffic assessment to include options for improved safety for the intersection of Van Ness and Clinton Avenues.
