A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO APPROVE STREET NAME CHANGE APPLICATION NO. SNC-2014-001

WHEREAS, in accordance with Section 12-1102 of the Fresno Municipal Code. Street Name Change Application No. SNC-2014-001 has been filed by Daniel Eisenberg, president of Irritec USA, Inc., to rename the portion of East Home Avenue between North Maple Avenue and North Backer Avenue to North Irritec Way; the portion of East Pine Avenue between North Maple Avenue and North Backer Avenue to North Irritec Way: the portion of North Backer Avenue between East Home Avenue and East Pine Avenue, to North Irritec Way:

WHEREAS, in accordance with the provisions of the "Street Name Procedure" Ordinance, Article 11 of Chapter 12 of the Fresno Municipal Code (FMC), staff reviewed the requested name change to an existing public street and recommended that the Fresno City Planning Commission support the request to rename the portion of East Home Avenue between North Maple Avenue and North Backer Avenue to North Irritec Way; the portion of East Pine Avenue between North Maple Avenue and North Backer Avenue to North Irritec Way; the portion of North Backer Avenue between East Home Avenue and East Pine Avenue, to North Irritec Way;

WHEREAS, the application is proposed pursuant to Section 12-1106 of the FMC. which allows the naming of streets for the purpose of honoring or calling attention to

persons or places having special prominence and significance to the culture or the history of the city;

WHEREAS, pursuant to the provisions of Section 12-1104 of the FMC, the Planning Commission of the City of Fresno held a public hearing on October 15, 2014, to consider Street Name Change Application No. SNC-2014-001 and related Environmental Assessment No. SNC-2014-001, during which the Commission recommended to the Council of the City of Fresno approval of the subject street name change application and environmental assessment as recommended by staff; and

WHEREAS, the Fresno City Council held a public hearing to consider Street Name Change Application No. SNC-2014-001 on October 30, 2014.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

- 1. The Council finds based upon its own independent judgment and determines with certainty that there is no possibility that Street Name Change Application No. SNC-2014-001 may have a significant effect on the environment pursuant to CEQA guidelines, Section 15061(b)(3), and hereby adopts the Finding of No Possibility of Significant Adverse Effect dated July 24, 2014.
- 2. The Council hereby approves Street Name Change Application No. SNC-2014-001, to rename the portion of East Home Avenue between North Maple Avenue and North Backer Avenue to North Irritec Way; the portion of East Pine Avenue between North Maple Avenue and North Backer Avenue to North Irritec Way; the portion of North Backer Avenue between East Home Avenue and East Pine Avenue, to North Irritec Way, as depicted on attached Exhibit 1.




EXHIBIT "1"
