

FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT (Amendment) made and entered into as of this 1st day of December 2024, amends the Agreement heretofore entered between the CITY OF FRESNO, a California municipal corporation (City), and AP Triton, LLC (Consultant).

RECITALS

WHEREAS, the City and the Consultant entered into an Agreement, dated March 5, 2024, for professional data analysis services for expert Community Analysis (CRA) and create a Community Risk Reduction (CRR) Plan (Project); and

WHEREAS, the City and Consultant desire to modify the Agreement to extend the term of Agreement period to February 23, 2025.

AGREEMENT

NOW, THEREFORE, the parties agree that the aforesaid Agreement be amended as follows:

1. Term of Agreement shall be extended to February 23, 2025.
2. In the event of any conflict between the body of the Amendment and any Exhibit or Attachment hereto, the terms and conditions of the body of this Amendment shall control and take precedence over the terms and conditions expressed within the Exhibit or Attachment. Furthermore, any terms of conditions contained within any Exhibit or Attachment hereto which purport to modify the allocation of risk between the Parties, provided for within the body of this Amendment, shall be null and void.
3. Except as otherwise provided herein, the Agreement entered into by the City and the Consultant on March 5, 2024, remains in full force and effect.
