NOTICE IS HEREBY GIVEN that the Fresno City Planning Commission, in accordance with Sections 65090 and 65091 (Planning and Zoning Law) of the Government Code and in accordance with the procedures of Article 50, Chapter 15, of the Fresno Municipal Code (FMC), will conduct a public hearing to consider the item below which pertain to approximately ±18.87 acres of property located northeast corner of West Barstow and North Contessa Avenues. The project was approved by the Planning and Development Director on September 6, 2023, and is being considered by the Planning Commission based upon appeals received from members of the public.

1. **Environmental Assessment No. P21-01833**, recommends that a Mitigated Negative Declaration dated September 5, 2023, for the proposed project be adopted pursuant to the State of California Environmental Quality Act (CEQA); and,
2. **Development Permit No. P21-01833**: Staff recommends the Planning Commission DENY the appeal and UPHOLD the action of the Planning and Development Department Director in approving Development Permit Application No. P21-01833.

All documents submitted to the Planning Commission for its consideration prior to or at the hearing shall be submitted to the Planning Commission at least 24 hours prior to the Commission agenda item being heard, pursuant to the Planning Commission rules and procedures, or they may be excluded from the administrative record of proceedings.

If you challenge the above application(s) in court, you may be limited to raising only those issues, you, or someone else, raised at the public hearing described in this notice, or in written correspondence delivered to the Development Services Division of the Planning and Development Department and/or Planning Commission/City Council at, or prior to, the public hearing. The environmental determination shall be considered by the City Council pursuant to FMC Section 15-5005-I.

NOTE: This public hearing notice is being mailed to surrounding property owners within 1,000 feet of the project site pursuant to the requirements of FMC Section 15-5007.




