BACKGROUND OF PROJECT (To be completed by Evaluating Department/Division. Explain need for project/equipment):

Pump Station 150 has decreased in production over the years and a well video revealed that the casing is severely plugged. We have installed a VFD and have extended the pump bowls 100 feet to prevent breaking suction due to severe drawdown from plugged well casing perforation. This well is worth 850 GPM when cleaned properly.

DEPARTMENT CONCLUSIONS AND RECOMMENDATION:

Award a contract in the amount of \$104,062.50 to Anderson Pump Company Inc. as the lowest responsive and responsible bidder.
