1. Requirements of the award; remedies for non-compliance or for materially false statements

The conditions of this award are material requirements of the award. any person or other entity, to violate any federal law, including any applicable civil rights or nondiscrimination law.

E. Nothing in this condition, including in paragraph 4.B., shall be understood to relieve any recipient, any subrecipient at any tier, or any person or other entity, of any obligation otherwise imposed by law, including 8 U.S.C. 1324a(a)(1) and (2).

13. Unreasonable restrictions on competition under the award; association with federal government

SCOPE. B. Nothing in this condition shall be understood to authorize or require any recipient, any subrecipient at any tier, or any person or other entity, to violate any federal law, including any applicable civil rights or nondiscrimination law.

19. Effect of failure to address audit issues
