

**FIRST AMENDMENT TO SERVICE AGREEMENT
CITY OF FRESNO, CALIFORNIA**

THIS FIRST AMENDMENT AGREEMENT is hereby made to the Service Agreement made and entered into between the CITY OF FRESNO, a California municipal corporation (hereinafter referred to as CITY), and The Arc Fresno/Madera Counties, a California non-profit corporation (hereinafter referred to as SERVICE PROVIDER) effective July 1, 2018 (Service Agreement).

RECITALS

WHEREAS, CITY and SERVICE PROVIDER contracted for certain trash pick-up services services for Fresno Yosemite International Airport, hereinafter referred to as the "Project;" and

WHEREAS, CITY and SERVICE PROVIDER now desire to revise Exhibit A to reflect accurate rates for SERVICE PROVIDER's services.

NOW, THEREFORE, in consideration of the foregoing and of the covenants, conditions, and premises hereinafter contained to be kept and performed by the respective parties, it is mutually agreed as follows:
