A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO MAKING THE SIXTH AMENDMENT TO RESOLUTION NO. 2025-177 ENTITLED "A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO ESTABLISHING RULES FOR THE APPLICATION OF CITY EMPLOYEE COMPENSATION RATES AND SCHEDULES AND RELATED REQUIREMENTS, AND ESTABLISHING COMPENSATION RATES AND SCHEDULES FOR FISCAL YEAR 2026"

SECTION 1.

Exhibit 5, Unit 5, Non-Management Fire (IAFF), is hereby amended to provide salary increases for respective classes as required by the adoption of the successor Memorandum of Understanding between the City of Fresno and International Association of Firefighters A.F.L.-C.I.O., Fresno City Firefighters Association, Local 202 (Non-Management Fire– Unit 5), effective September 8, 2025.

SECTION 2.

Exhibit 5, Unit 5, Non-Management Fire (IAFF), is hereby amended to provide salary increases for respective classes as required by the adoption of the successor Memorandum of Understanding between the City of Fresno and International Association of Firefighters A.F.L.-C.I.O., Fresno City Firefighters Association, Local 202 (Non-Management Fire– Unit 5), effective December 29, 2025, if the contingencies are met.


SECTION 3.

Exhibit 5, Unit 5, Non-Management Fire (IAFF), is hereby amended to provide salary increases for respective classes as required by the adoption of the successor Memorandum of Understanding between the City of Fresno and City and International Association of Firefighters A.F.L.-C.I.O., Fresno City Firefighters Association, Local 202 (Non-Management Fire– Unit 5), effective June 15, 2026.

SECTION 4.

Upon final legislative approval, this Resolution shall become effective September 8, 2025.
