iii. PROJECT REVIEW – CONTINUED MATTERS

iv. PROJECT REVIEW – NEW MATTERS

A: Workshop - Text Amendment Application No. P24-01100 proposes to amend the Citywide Development Code and modify Section 15-2706; otherwise known as the Responsible Neighborhood Market Act (RNMA). The RNMA provides regulations relating to the establishment of alcohol licenses and the sale of alcoholic beverages for off-site consumption. The proposed text amendment would allow flexibility for full-service grocery stores seeking to operate by allowing an additional exception to the Location Restrictions and an exemption to the Cancel & Transfer Provisions. In addition, the proposed text amendment defines Full-Service Grocery Store and its exclusions.

Staff was in attendance and presented the item.

A master roll call vote was made for the approval of item 4A. The motion passed 3 votes to 0.

Chair Rabara, Committee Member Vasquez, and Committee Baroni approved the project as is with no further comment or recommendations.

B: Approval – Development Permit Application No. P24-01038 was filed by Elias Saliba of Aesthetics Design on behalf of Kaur Jaswinder and Khushpal Singh and pertains to the ±2.77 acres located at 6000 East Jensen Avenue, Fresno CA, 93725. The applicant proposes to construct a Multifamily development consisting of (22) townhouse/carriage row houses, and (22) condos in a 3-story residential tower with elevator totaling to 44 dwelling units. In addition, a ± 2,000 square foot community building with a ± 1,000 square foot covered patio and swimming pool will be constructed along with the drive approach, curb, gutter, and landscaping. The property is zoned RM-1/UGM (*Residential Multi-Family, Medium High Density/Urban Growth Management*).

The applicant was in attendance and presented the item.

A master roll call vote was made for the approval of item 4B. The motion passed 3 votes to 0.

Chair Rabara, Committee Member Vasquez, and Committee Baroni approved the project with the recommendation of cementing the trail in the front of the property along Jensen.
