A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING ACCEPTANCE OF FUNDING FROM THE STATE OF CALIFORNIA DEPARTMENT OF TOXIC SUBSTANCES CONTROL'S OFFICE OF BROWNFIELDS EQUITABLE COMMUNITY REVITALIZATION GRANT IN THE AMOUNT OF \$3,122,648 FOR THE REMEDIATION OF THE 1457 H STREET SITE AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO ENTER INTO AND EXECUTE A GRANT AGREEMENT

WHEREAS, the State of California Department of Toxic Substances Control's (DTSC)'s Office of Brownfields issued an Equitable Community Revitalization Grant (ECRG) Round 2 Guidelines soliciting applications on August 14, 2023, to implement the Cleanup in Vulnerable Communities Initiative under Senate Bill 158 (Chapter 73, Statutes of 2021) allocating \$500 million to DTSC for the cleanup and beneficial reuse of properties in historically vulnerable and disadvantaged communities; and

WHEREAS, the Council of the City of Fresno adopted Resolution Number 2023-268 on October 5, 2023, authorizing and directing the submission of a grant application to the DTSC's ECRG Round 2 solicitation for applications, to facilitate the remediation of the 1457 H Street site, and authorizing the City Manager, or designee, to execute the application and all other necessary documents; and

WHEREAS, on March 18, 2024, the City of Fresno received a Notice of Award of ECRG Round 2 Grant Funds in the amount of \$3,122,648 and request for signature from the City Manager, or designee, on the ECRG Agreement.
