A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO MAKING THE THIRTEENTH AMENDMENT TO RESOLUTION NO. 2024-120 ENTITLED "A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO ESTABLISHING RULES FOR THE APPLICATION OF CITY EMPLOYEE COMPENSATION RATES AND SCHEDULES AND RELATED REQUIREMENTS, AND ESTABLISHING COMPENSATION RATES AND SCHEDULES FOR FISCAL YEAR 2025"

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Fresno, as follows:

SECTION 1.

Exhibit 1, Unit 1 – Non-Supervisory Blue Collar (Local 39), is hereby amended to correct the salary increases for Senior Water Treatment Plant Operator and Water Treatment Plant Operator as required by Memorandum of Understanding between the City of Fresno and International Union of Operating Engineers, Stationary Engineers, Local 39 (Local 39), retroactively effective June 17, 2024.

SECTION 2.

Exhibit 1, Unit 1 – Non-Supervisory Blue Collar (Local 39), is hereby amended to correct the salary increases for Senior Water Treatment Plant Operator and Water Treatment Plant Operator as required by Memorandum of Understanding between the City of Fresno and International Union of Operating Engineers, Stationary Engineers, Local 39 (Local 39), retroactively effective December 30, 2024

SECTION 3.

Exhibit 3, Unit 3, Non-Supervisory White Collar (FCEA), is hereby amended to modify the salary step plan range for the classifications of Administrative Clerk I from \$2,853 - \$3,410 to \$2,860 - \$3,410 monthly, Senior Secretary from \$4,103 - \$4,928 to \$4,120 - \$4,944 monthly, Staff Assistant from \$4,109 - \$4,129 to \$4,120 - \$4,944 monthly, and deleting the classification of Secretary, effective February 24, 2025.
