The Project was initiated in Fiscal Year 2022. Project design was performed in-house by City staff. CPD has identified 8-inch, and 6-inch diameter water mains located in the area bound by Orange, Church, Cedar and Jensen Avenues that may be prone to unexpected failures due to inferior steel water mains installed as early as 1934. The scope of work includes replacement of 10,923 linear feet of 8-inch and 98 linear feet of 6-inch diameter water mains, fire hydrants, valves and service transfers. This Project is funded by the Water Enterprise Fund
