RESOLUTION NO. 99-324

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, PLACING THE WILD RESIDENCE,
LOCATED AT 567 EAST CLINTON AVENUE TO THE LOCAL
OFFICIAL REGISTER OF HISTORIC RESOURCES**

WHEREAS, the Wild Home, located at 567 East Clinton Avenue is an outstanding example in Fresno of the English Tudor style of architecture; and

WHEREAS, the home exhibits a quality of design and craftsmanship completed at a very high level; and

WHEREAS, the home, constructed in 1929, retains a high degree of architectural integrity; and

WHEREAS, the home contributes to the proposed Terrace Gardens Historic District and was determined in the Tower District Specific Plan of 1991 to be a "Primary Resource" for the Tower District; and

WHEREAS, the home is associated with a prominent and important local attorney, Mount K. Wild, and his wife, Doris Ludlow Wild, a female designer of great ability; and

WHEREAS, Fresno's Historic Preservation Commission, at a noticed public hearing held on October 25, 1999, heard testimony on the subject property; and

WHEREAS, based on that testimony, and presentation of facts relating to the criteria for official designation, as set forth in the Fresno Municipal Code, Article 4, Section 13-407, made the following findings;

The Wild Residence, located at 567 East Clinton Avenue is eligible
for inclusion in Fresno's Local Official Register of Historic Resources; and
Recommend to the City Council the addition of the property to the register.

NOW, THEREFORE, BE IT RESOLVED, that the City Council for the City of Fresno hereby designates the Wild Residence, located at 567 East Clinton Avenue to the Local Official Register of Historic Resources.
