

RESOLUTION NO. 2024-120

A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO MAKING THE FIFTH AMENDMENT TO RESOLUTION NO. 2024-120 ENTITLED "A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO ESTABLISHING RULES FOR THE APPLICATION OF CITY EMPLOYEE COMPENSATION RATES AND SCHEDULES AND RELATED REQUIREMENTS, AND ESTABLISHING COMPENSATION RATES AND SCHEDULES FOR FISCAL YEAR 2025"

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Fresno, as follows:

SECTION 1.

Exhibit 8, Unit 8, Non-Represented, is hereby amended to remove Airports Public Safety Officers and Airport Public Safety Supervisors from the exhibit as required by the adoption of the Memorandum of Understanding between the City and Fresno Airport Public Safety Officers Association (FAPSOA – Unit 11), retroactively effective July 1, 2024.

SECTION 2.

Section 13, Salary Rates, is hereby amended to add Exhibit 11 - Fresno Airport Public Safety Officers Association as required by the adoption of the Memorandum of Understanding between the City and Fresno Airport Public Safety Officers Association (FAPSOA – Unit 11), retroactively effective July 1, 2024.


SECTION 3.

Section 18 is hereby amended to remove the benefits and terms and conditions for Airport Public Safety Officers and Airport Public Safety Supervisors as required by the adoption of the Memorandum of Understanding between the City and Fresno Airport Public Safety Officers Association (FAPSOA – Unit 11), retroactively effective July 1, 2024.

SECTION 4.

Exhibit 11, Unit 11, Fresno Airport Public Safety Officers Association, is hereby added to provide salary increases for respective classes as required by the adoption of the Memorandum of Understanding between the City and Fresno Airport Public Safety Officers Association (FAPSOA – Unit 11), retroactively effective July 1, 2024.
