SUPPLEMENTAL FREEWAY AGREEMENT

1 This Agreement, made and entered into, in duplicate
2 this 20th day of February, 1964, by and between
3 the State of California, acting by and through the Highway
4 Transportation Agency, Department of Public Works, Division of
5 Highways, hereinafter for convenience referred to as "the State,"
6 and the City of Fresno, hereinafter for convenience referred to
7 as "the City,"

W I T N E S S E T H:

9 WHEREAS, the State and City have heretofore entered
10 into a Freeway Agreement dated May 5, 1960, relating to that
11 certain portion of State Highway Route 4 in the City of Fresno,
12 between the south city limit of Fresno and Inyo Street; and

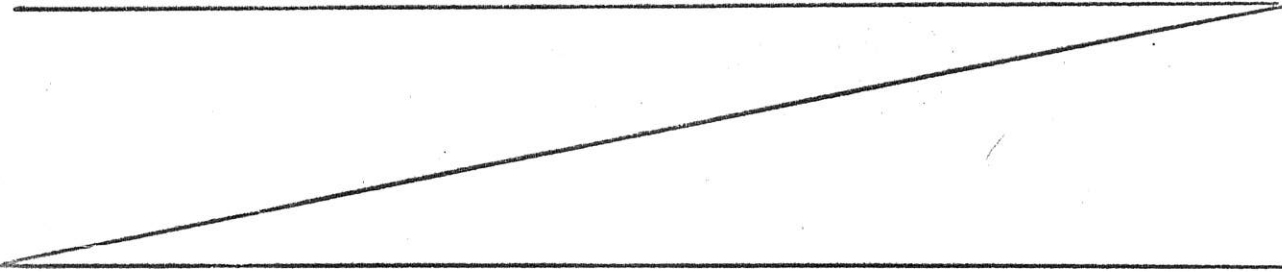
13 WHEREAS, the plan of construction, as shown on "Revised
14 Exhibit A" (File No. F-103-R2 dated May 1960) attached to said
15 agreement, has been altered in certain respects since the date
16 of execution of said agreement; and

17 WHEREAS, a new plan map has been prepared showing the
18 altered plan of construction;

19 NOW, THEREFORE, IT IS AGREED:

20 1. That the plan map attached hereto, marked "Revised
21 Exhibit A" (File No. F-103-R3 dated January 1964) shall be
22 substituted for "Revised Exhibit A" (File No. F-103-R2 dated
23 May 1960) attached to the Freeway Agreement dated May 5, 1960,
24 and become a part of said agreement for all purposes.

25 2. That except for the substitution of the revised



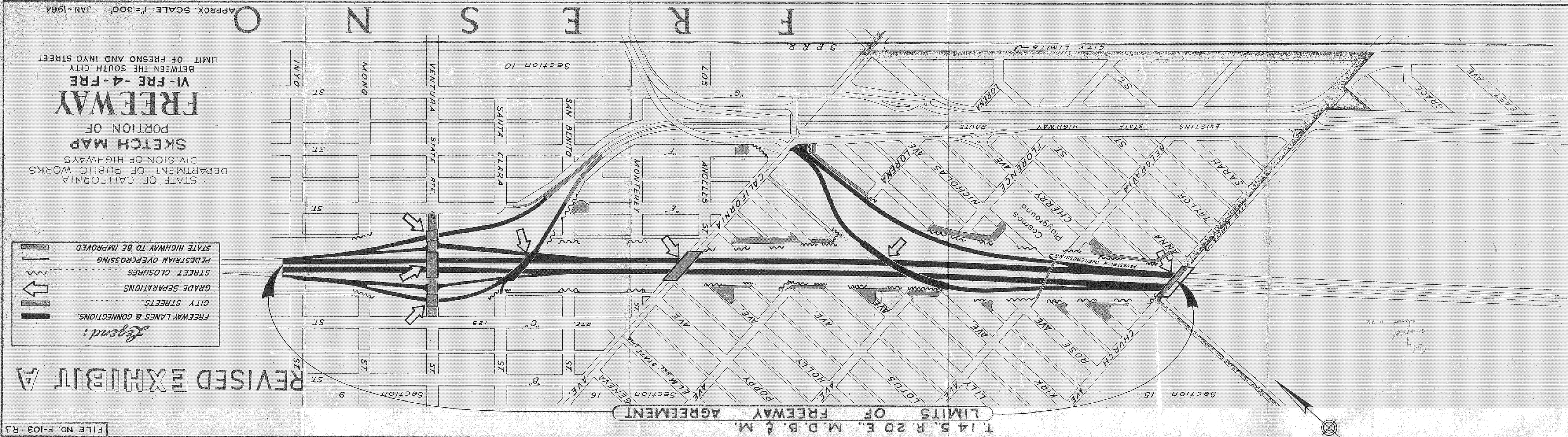
