SUPPLEMENTAL PREEWAY AGREEMENT

This Agreement, made and entered into, in duplicate this 20th day of February, 1964, by and between the State of California, acting by and through the Highway Transportation Agency, Department of Public Works, Division of Highways, hereinafter for convenience referred to as "the State," and the City of Fresno, hereinafter for convenience referred to as "the City."

WITNESSETH:

WHEREAS, the State and City have heretofore entered into a Freeway Agreement dated May 5, 1960, relating to that certain portion of State Highway Route 4 in the City of Fresno, between the south city limit of Fresno and Inyo Street; and

WHEREAS, the plan of construction, as shown on "Revised Exhibit A" (File No. F-103-R2 dated May 1960) attached to said agreement, has been altered in certain respects since the date of execution of said agreement; and

WHEREAS, a new plan map has been prepared showing the altered plan of construction;

NOW, THEREFORE, IT IS AGREED:

- 1. That the plan map attached hereto, marked "Revised Exhibit A" (File No. F-103-R3 dated January 1964) shall be substituted for "Revised Exhibit A" (File No. F-103-R2 dated May 1960) attached to the Freeway Agreement dated May 5, 1960, and become a part of said agreement for all purposes.
 - 2. That except for the substitution of the revised

plan map, said Freeway Agreement dated May 5, 1960, shall remain
