A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, TO ADOPT THE WASTEWATER
COLLECTION SYSTEM MASTER PLAN UPDATE

RECITALS

WHEREAS, the City of Fresno Department of Public Utilities Sewer Enterprise (DPU) owns, operates, maintains and expands the Sewer Collection System consisting of approximately 1,536 miles of collection system pipe ranging in size from 4 to 84 inches in diameter, and more than 24,000 manholes; and

WHEREAS, the State Water Resources Control Board Order No 2006-0003-DWQ, Statewide General Waste Discharge Requirements for Sanitary Sewer Systems requires all federal and state agencies, municipalities, counties, districts, and other public entities that own or operate sanitary sewer systems greater than one mile in length that collect and/or convey untreated or partially treated wastewater to a publicly owned treatment facility in the State of California are required to develop and implement a written Sewer System Management Plan (SSMP); and

WHEREAS, the SSMP content requirements detailed in section (viii) contain:

- (a) An evaluation of those portions of the sanitary sewer system that are experiencing or contributing to an Sanitary System Overflow discharge caused by hydraulic deficiency;
- (b) The definition of design criteria;
- (c) The development of a rehabilitation and replacement plan to identify and prioritize system deficiencies and implement short-term and long-term rehabilitation actions to address each deficiency;
- (d) The development of a schedule of completion dates for all portions of the capital improvement program developed in (a)-(c) above.

WHEREAS, the City prepared a Wastewater Collection System Master Plan Update to meet the requirements of the SSMP as detailed above;

WHEREAS, the City last prepared a Wastewater Collection System Master Plan in 2006;

WHEREAS, DPU prepared the Wastewater Collection System Master Plan Update to include the current state of the system and projected demands associated with the General Plan update and meet the requirements of the SSMP;
