Conditional Use Permit Application No. P25-03031 was filed by Ahmed Zuwawa of Kimley-Horn on behalf of Andy Greenwood of Macerich / Fashion Fair Mall and pertains to approximately  $\pm$  2.71 acres of property located at 755 East Shaw Avenue, Fresno, CA 93710; APN: 42703037. The project proposes to demolish the existing east side anchor building--formerly Forever 21-and construct a new two-level,  $\pm$  122,000 square foot anchor building with associated  $\pm$  18,500 square foot outdoor multi-purpose area. The project further proposes parking lot enhancements and pedestrian amenities in the immediate area surrounding the new structure. The parcel is zoned CR (Commercial Regional).
