Upon call, the following members of the public addressed Council: Rosa De Leon, and Jovana Morales

Council President Karbassi made the following announcement: Council adopted 82 Budget motions which resulted in the General Fund for the proposed Fiscal Year 2026 Budget being out of balance. The Administration has worked to develop a resolution that would allow the Council to adopt a balanced budget as required by the City Charter. The Annual Appropriations Resolution and related budget documents for consideration will accomplish the balanced budget requirement. A reconciliation summary sheet outlining the changes is attached to the Budget AAR as Exhibit B and has been distributed along with the budget documents.

Discussion was held between Council and the administration.

Council President Karbassi motioned to ADOPT the 9:00 A.M. budget items, A through G, including the changes made pursuant to the FY26 Budget Reconciliation Summary identified as Exhibit B to the Annual Appropriations Resolution.
