A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE SUBMISSION OF GRANT APPLICATIONS TO UNITED STATES DEPARTMENT OF TRANSPORTATION (DOT) STRENGTHENING MOBILITY AND REVOLUTIONIZING TRANSPORTATION (SMART) GRANTS PROGRAM FOR SMART CITY OR COMMUNITY TECHNOLOGIES AND SYSTEMS PROJECTS TOTALING UP TO \$2 MILLION IN REQUESTS OF GRANT APPLICATION FUNDING AND AUTHORIZING THE EXECUTION OF GRANT APPLICATION AND GRANT AGREEMENT DOCUMENTS BY THE PUBLIC WORKS DIRECTOR OR DESIGNEE(S)

WHEREAS the City of Fresno is an eligible applicant of Strengthening Mobility and Revolutionizing Transportation Grant funds; and

WHEREAS, the United States Department of Transportation has issued a call for projects for fiscal years 2022-2026 for an estimated available funding of \$100 million; and

WHEREAS, the United States Department of Transportation has issued a call for projects for fiscal year 2023 for an estimated available funding up to \$2 million.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council approves and supports the applications for grant funding up to \$2 million from the United States Department of Transportation Strengthening Mobility and Revolutionizing Transportation Grant Program for the projects and participation therein consistent with constitutional and local law requirements and this resolution.

2. The Council acknowledges that the City has reviewed, understands and to the extent consistent with all constitutional and local law requirements and this resolution,
