Edward Saliba – Fresno Madera Area Agency On Aging Board

Mr. Saliba is administrator of Valley Adult Day Health Care, which is located at 1052 C St. in Fresno. He has held this position for 18 years.

He was first appointed in 2017 and has completed one term. Prior to being appointed to the Fresno Madera Area Agency on Aging's governing board, he served on the FMAAA advisory board

Valley Adult Day Health Care works with adults who require assistance in health maintenance and to either improve or maintain their functional abilities. The services it provides are to maintain, improve, and prolong a person's ability to function without requiring 24-hour care and to keep them from being placed into some type of assisted living facility. Valley ADHC works agencies such as the CA Department of Aging and the Central Valley Regional Center. It's service area is Shields Avenue on the north, DeWolf Avenue on the east, North Avenue on the south, and Highway 99 on the west.

Mr. Saliba has a BA in Business Administration from the American University of Beirut, Lebanon and has done post-graduate courses at California State Fullerton.

Paul J. Bauer – Fresno Regional Workforce Development Board

Mr. Bauer is a labor and employment law attorney with Sagaser, Watkins & Wieland PC

He was first appointed to the board in October 2009 and has served 5 two-year terms.

Mr. Bauer consults and represents employers in business and employment litigation, including wrongful termination, sexual harassment, wage and hour violations, and many forms of discrimination.

Mr. Bauer advises employers on labor compliance and litigation prevention measures. He trains employers on preventing harassment and other Equal Employment Opportunity issues in the workplace. He has defended private and public employers against employment-related lawsuits before state and federal courts. He served as a

policy consultant to former California State Senator Charles S. Poochigian, advising members on legislation affecting employers.

Mr. Bauer is the current chair of the Fresno Regional Workforce Development Board and is president of the Central California Employment Round Table.

Mr. Bauer has a BA in Public Administration, with a minor in Economics, from Fresno State and earned his JD from McGeorge School of Law (University of the Pacific) in 1999. He is a member of the California State Bar as well as admitted to practice in the U.S. District Court Eastern District of California, U.S. Court of Appeals 9th Circuit, and U.S. District Court Northern District of California, 2004
