

## FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT (Amendment) made and entered into as of this 16 day of December, 2024, (Effective Date) amends the Agreement entered into between the City of Fresno, a California municipal corporation (City), and Pavletic Consulting LLC, a Texas Domestic Limited Liability Company, (Consultant).

### RECITALS

WHEREAS, the City and Consultant, previously Municipal Financial Services, entered into an agreement on February 1, 2022, (Agreement) to provide consulting services for professional utility rate plan consulting services for Five-Year Rate Plan – Water and Wastewater (Project); and

WHEREAS, the City and Consultant desire to extend the term of the Agreement to June 30, 2025, to allow Consultant to complete the scope of work; and

WHEREAS, since execution of the Agreement, Consultant has changed its business organization. Consultant previously operated as Municipal Financial Services, a sole proprietorship but has now formed Pavletic Consulting LLC, a Texas Domestic Limited Liability Company; and

WHEREAS, with entry into this Agreement, the Consultant agrees it has no claim, demand, or dispute against the City.

### AGREEMENT


NOW, THEREFORE, the parties agree that the aforesaid Agreement be amended as follows:

1. The recitals to this Amendment are incorporated and made a part of the Agreement.
2. Section 2 of the Agreement is amended to read as follows:  
“Term of Agreement and Time for Performance. This Agreement shall be effective from the date first set forth above (Effective Date) and shall continue in full force and effect through June 30, 2025, subject to any earlier termination in accordance with this Agreement. The services of the Consultant as described in **Exhibit A** are to commence upon the Effective Date and shall be completed in a sequence assuring expeditious completion, but in any event, all such services shall be completed prior to expiration of this Agreement and in accordance with any performance schedule set forth in **Exhibit A**.”
3. Except as otherwise provided herein, the Agreement entered into by the City and the Consultant on February 1, 2022, remains in full force and effect.




