RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE PUBLIC WORKS DIRECTOR OR DESIGNEE TO SUBMIT A GRANT APPLICATION IN AN AMOUNT NOT TO EXCEED \$400,000 FOR THE 2024-2025 CALIFORNIA DEPARTMENT OF TRANSPORTATION (CALTRANS) SUSTAINABLE TRANSPORTATION PLANNING GRANT (STPG) PROGRAM TO FUND THE DEVELOPMENT OF A MOBILITY DESIGN GUIDE, AND AUTHORIZING THE EXECUTION OF GRANT AGREEMENT AND APPLICATION RELATED DOCUMENTS AND ACCEPTING THE GRANT AND COMPLETING GRANT AGREEMENT DOCUMENTS BY THE PUBLIC WORKS DIRECTOR OR DESIGNEE.

WHEREAS, the Sustainable Transportation Planning Grant Program provides grant funds to eligible local agencies for the purpose of transportation planning;

WHEREAS, the California Department of Transportation administers the program and has requested applications from eligible agencies; and

WHEREAS, the City of Fresno is eligible to receive Federal and/or State funding for transportation planning through the California Department of Transportation; and

WHEREAS, the development of a City of Fresno Mobility Design Guide would be a critical and consolidated resource document centralizing design elements, specifications, and standards for mobility related engineering design, layout, and uses within our community streets including but not limited to: bicycle and pedestrian facilities, personal mobility devices, transit, and mobility hubs; and

WHEREAS, a City of Fresno Mobility Design Guide would provide a roadmap along with a toolbox of how to enhance safety, livability, and economic opportunities along streets in the City of Fresno, visualizing the City's Complete Streets Policy; and

WHEREAS, a Restricted Grant Agreement would need to be executed with the California Department of Transportation before funds can be claimed through the Transportation Planning Grant Programs.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Approves the application for grant funding from the Sustainable Transportation Planning Grant Program for a City of Fresno Mobility Design Guide and participation therein consistent with constitutional and local law requirements and this resolution.

2. Certifies, consistent with constitutional and local law requirements and this resolution that the City has or will have sufficient funds to provide the matching funds required.

3. Certifies that the City has reviewed, understands and to the extent consistent with all constitutional and local law requirements and this resolution, agrees to the provisions contained in the application and program guidelines and related documents.

4. Appoints and authorizes the Director of Public Works or designee, and each of them as agents for the City of Fresno, to execute and submit all Restricted Grant Agreements and any amendments for the project thereto with the California Department of Transportation, subject to prior approval as to form by the City Attorney's Office.

5. This resolution shall be effective upon final approval.
