A RESOLUTION OF THE COUNCIL OF THE CITY OF  
FRESNO, CALIFORNIA, DECLARING ELECTION RESULTS

**COMMUNITY FACILITY DISTRICT NO. 17**

WHEREAS, on May 21, 2020, the Council of the City of Fresno adopted Council Resolution No. 2020-\_\_\_\_\_ calling a special mailed-ballot election on levying special taxes on land within, and on approving an annual appropriations limit for Community Facilities District No. 17 (CFD No. 17); and

WHEREAS, the Council has received, reviewed, and hereby accepts the City Clerk's Canvass and Statement of Results of Election, dated May 21, 2020, a copy of which is attached as Exhibit A.

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council finds and declares that: (a) the ballot measure on the levy of special taxes and approval of an annual appropriations limit for CFD No. 17, was submitted to the qualified electors within the area of CFD No. 17, pursuant to Council Resolution No. 2020-\_\_\_\_\_, and (b) the ballot measure has been passed and approved by more than two-thirds of the votes cast, in accordance with the City of Fresno Special Tax Financing Law, Chapter 8, Division 1, Article 3 of the Fresno Municipal Code ("City Law").

2. The Council declares CFD No. 17, to be fully formed and the property within CFD No. 17, to be subject to the levy of the special taxes, the special tax lien, and

appropriations limit described in Council Resolution No. 2020-\_\_\_\_\_, Resolution of Formation of CFD No. 17, Authorizing the Levy of a Special Tax Therein; and approving local goals and policies for Community Facilities (Service) Districts; and described in the Community Facilities Districts Report dated as of April 24, 2020, on file with the City Clerk.

3. The Council directs the City Clerk to record a notice of special tax lien in the Office of the County Recorder, pursuant to City Law, no later than 15 days after this resolution is adopted.
