A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO ESTABLISHING THE PRAC GRANT GUIDELINES
AD HOC COMMITTEE

WHEREAS, Measure P expanded access to parks, recreation, and arts and created the Parks, Recreation, and Arts Commission; and

WHEREAS, parks, recreation, and cultural arts are matters of public interest and serve essential roles in the City; and

WHEREAS, expanding access to arts grants is a key component of Measure P; and

WHEREAS, arts grants have been traditionally awarded through specific grant guidelines; and

WHEREAS, updated arts grant guidelines are currently being circulated in draft form; and

WHEREAS, by creating this ad hoc committee the Council will create an entity to review the arts grant guidelines and make recommendations to Council before the guidelines are adopted.

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The PRAC Grant Guidelines Ad Hoc Committee (the Committee) is hereby established.
2. The legal authority for creation of the Committee is Charter Section 900, Charter Section 500, Resolution 2024-040.

3. The Purpose of the Committee is to review draft grant guidelines for the Parks, Recreation, and Arts Commission and provide feedback and recommendations to the full Council by its regular June 18, 2026 meeting

4. The Committee shall be an advisory body. (Advisory means the body is formed or engaged for the sole purpose of researching a topic and preparing a report or recommendation for another public official or legislative body that has final decision-making authority.)

5. The Committee shall continue to exist for two weeks, after which it will automatically dissolve.

6. The membership shall consist of:

- a. Three Councilmembers.
- b. The members shall be appointed by the City Council President.

7. No additional compensation will be paid for membership on this Committee.

8. This resolution shall be effective upon final approval.
