A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO MAKING THE THIRD AMENDMENT TO RESOLUTION NO. 2022-152 ENTITLED "A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO ESTABLISHING RULES FOR THE APPLICATION OF CITY EMPLOYEE COMPENSATION RATES AND SCHEDULES AND RELATED REQUIREMENTS, AND ESTABLISHING COMPENSATION RATES AND SCHEDULES FOR FISCAL YEAR 2023"

SECTION 1.

Section 9 - Annual Leave for Employees in Exhibit 2, subsection 1.b, is hereby amended to include the new E13 Executive Pay Range, effective October 3, 2022.

SECTION 2.


Exhibit 2, Non-Represented Management and Confidential Classes, is hereby amended to add the new classification of Project Liaison/Program Administrator and provide a new E13 salary range of \$9,766 - \$12,501 per month for the respective class, effective October 3, 2022.

SECTION 3.

Exhibit 2, Non-Represented Management and Confidential Classes, is hereby amended to retitle the Labor Relations Manager classification to the Chief Labor Negotiator classification and increase the salary range from E7 to E6, effective October 3, 2022.

SECTION 4.

Exhibit 2, Non-Represented Management and Confidential Classes, is hereby amended to increase the Deputy City Manager classification salary range from E7 to E6, effective October 3, 2022.
