

FIRST AMENDMENT TO AGREEMENT

This FIRST AMENDMENT TO AGREEMENT (Amendment) made and entered into as of this ____ day of _____, 2025 (Effective Date), amends the Agreement entered into by and between the City of Fresno, a California municipal corporation (City), and UBEO West LLC. (Provider)

RECITALS

WHEREAS, City and Provider entered into an agreement on December 9, 2021, (Agreement) with Ray Morgan Company, LLC (Now UBEO) to provide and maintain copier/multifunctional devices for all City divisions for a period of five years with an option for four one-year extensions; and

WHEREAS, the Agreement did not go into effect until July 1, 2022, due to Provider's administrative processes related to billing; and

WHEREAS, City and Provider now desire to amend the Agreement to extend until July 1, 2029, for compensation not to exceed \$512,600 per year for additional equipment and services at a favorable price guaranteed not to increase for four years; and

WHEREAS, with entry into this Agreement, the Provider agrees it has no claim, demand, or dispute against the City.

AGREEMENT

NOW, THEREFORE, the parties agree that the Agreement be amended as follows:

1. The recitals of this Amendment are incorporated and made a part of the Agreement.
2. Provider shall provide the additional equipment and services as described in **Exhibit A and C**, attached hereto and incorporated herein by reference.
3. The term of the Agreement shall be extended from July 1, 2027, to July 1, 2029.
4. Compensation. The parties acknowledge the compensation provided in the Agreement is hereby increased to \$512,600 annually, for a total contract amount not to exceed \$3,209,000.
5. Except as expressly modified by this Amendment, the Agreement remains in full force and effect. In the event of any conflict between the Agreement and this Amendment, this Amendment shall control.
