A RESOLUTION OF THE COUNCIL OF THE CITY OF  
FRESNO, CALIFORNIA, DECLARING THE RESULTS OF  
THE CONSOLIDATED DIRECT PRIMARY ELECTION HELD  
WITHIN THE CITY OF FRESNO ON MARCH 3, 2020

WHEREAS, on March 3, 2020 a Consolidated Direct Primary election was held in  
the City of Fresno, pursuant to Section 1400 of the Charter of the City of Fresno; and

WHEREAS, the Council met at the hour of 9:00 a.m. on April 9, 2020, at its usual  
meeting place to declare the results of such election; and

WHEREAS, the Fresno County Clerk has canvassed the returns of the  
Consolidated Direct Primary election; and

WHEREAS, the Fresno County Clerk has prepared and presented to the Council  
a certified abstract of canvassed returns setting forth the results of the election.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as  
follows:

1. The certified statement of votes cast heretofore presented to this Council  
by the Fresno County Clerk is accepted and adopted as the official canvass of the returns  
of the March 3, 2020 Consolidated Direct Primary election held in the City of Fresno, and  
the Council finds, determines, and declares the results of the returns of the election as  
follows:

- a. The whole number of votes cast in the City, the names of the persons  
voted for, and for what office each person was voted for, are set forth  
in the attached certified abstract (Exhibit A), which is on file with the  
City clerk and hereby made a part hereto as if fully set forth herein.
