

**FIRST AMENDMENT TO  
CONSULTANT SERVICES AGREEMENT BETWEEN  
THE CITY OF FRESNO AND GHD INC.**

This First Amendment to Agreement for Consultant Services (Amendment) entered into on \_\_\_\_\_, 2026, (Effective Date), amends the Agreement entered into between the City of Fresno, a California municipal corporation (City), and GHD, Inc., a California Corporation (Consultant).

**RECITALS**

WHEREAS, the City and the Consultant entered into a Consultant Services Agreement on December 12, 2024, (Agreement) for the 1457 H Street Cleanup (Project); and

WHEREAS, the Agreement established a term that is set to expire on March 20, 2026; and

WHEREAS, the City applied for and was awarded a grant operation extension period ending on October 7, 2027; and

WHEREAS, the City desires to extend the term of the Agreement to align with the grant operation period and allow the Consultant to continue providing services necessary for the successful completion of the grant-funded activities; and

WHEREAS, an extended project schedule is reflected in the Revised Project Schedule, attached hereto and made a part hereof; and

WHEREAS, amending the Agreement will assist the City to fulfill its requirements and obligations under the Equitable Community Revitalization Grant (ECRG) Program.

WHEREAS, with entry into this Agreement, the Consultant agrees it has no claim, demand, or dispute against the City.

**AGREEMENT**

NOW, THEREFORE, in consideration of the above recitals, which recitals are contractual in nature, the mutual promises herein contained, and for other good and valuable consideration hereby acknowledged, the parties agree to the following:

1. The Term of this Agreement shall be extended through October 7, 2027, unless terminated earlier as provided herein.
2. The Project Schedule attached to the Agreement is hereby stricken and replaced with the Revised Project Schedule, attached hereto as Exhibit A and incorporated herein.
3. Except as expressly modified and amended hereby, the Agreement shall remain in full force and effect. From and after the effective date of this First Amendment, references in the Agreement to "this Agreement" shall mean the Agreement as hereby amended.
