A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO AMEND RESOLUTION 84-142, AS AMENDED BY RESOLUTION 89-470 AND 94-114. ALLOWING FOR THE PUBLIC WORKS DIRECTOR TO DELEGATE THE AUTHORITY TO OTHER DEPARTMENTS TO APPROVE CONTRACT CHANGE **ORDERS** FOR ON-SITE **PUBLIC** WORKS CONSTRUCTION

WHEREAS, Resolution 84-142, dated April 24, 1984, established procedures for the approval of certain Contract Change orders including the dollar amounts;

WHEREAS, Resolution 89-470, dated December 12, 1989, and Resolution 94-114, dated May 17, 1994, amended the previously approved Resolution increasing the Charge Order authority amounts (collectively "Resolutions"); and

WHEREAS, the Public Works Director may delegate his or her authority granted by the Resolutions to approve Contract Change orders for on-site work to other City Department Directors.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

- With the Public Works Director's written permission, other City Department
   Directors may self-perform or hire third party construction management for their on-site
   public work of improvement.
- 2. The Public Works Director shall be signatory to the Report to Council when hiring third party construction management.

- 3. The delegated City Department Director shall be authorized to sign the construction agreement, issue monetary or time extensions change orders as outlined in the Resolutions.
- 4. The delegated City Department Director shall be authorized to resolve claims and disputes which may arise for the public work of improvement.
- 5. The delegated City Department Director shall be required to follow prevailing wage monitoring requirements.
- 6. The delegated Department Director shall have a person who is in responsible charge of the work as required by the State of California Business and Professions Code Section 6700.
- 7. The delegated authority shall extend only to on-site work. The authority shall not extend to work within the City street right-of-way.
