

**FIRST AMENDMENT TO  
AGREEMENT**

THIS FIRST AMENDMENT TO AGREEMENT (Amendment) made and entered into effect the 1st day of June, 2017, (Effective Date) amends the Agreement heretofore entered into between the CITY OF FRESNO, a California municipal corporation (City), and California C.A.D. Solutions, Inc., a California corporation (Consultant).

**RECITALS**

WHEREAS, the City and the Consultant entered into an agreement on November 1, 2016, (Agreement) to provide professional GIS and Database services for Conversion of GIS Data from OSE to FDO (Project); and

WHEREAS, the City and the Consultant desire to extend the Agreement to November 30, 2017, to complete Project; and

WHEREAS, with entry into this Agreement, the Consultant agrees the Consultant has no claim, demand, or dispute against the City.

**AGREEMENT**

NOW, THEREFORE, in consideration of the above recitals, which recitals are contractual in nature, the mutual promises herein conditioned, and for other good and valuable consideration hereby acknowledge, the parties agree that the aforesaid Agreement be amended as follows:

1. The recitals to this Amendment are incorporated and made a part of this Amendment.
2. The term of the Agreement shall be extended from June 30, 2017, up to and including November 30, 2017.
3. Except as otherwise provided herein, the Agreement entered into by the City and the Consultant on November 1, 2016, respectively, remains in full force and effect.




