1. ***RESOLUTION - Adopting Substantial Amendment 2019-06 to the 2019-2020 Annual Action Plan and COVID-19 Amendments to the Citizen Participation Plan to submit a request to HUD to program \$7,980,086 of Community Development Block Grant-Coronavirus (CDBG-CV) funds to prevent, prepare for, and respond to the Coronavirus (COVID-19); approving allocations to activities in accordance therewith; and authorizing the City Manager or designee to sign all implementing documents as approved to form by the City Attorney (Subject to Mayor's veto)
2. Approve first revision of ESG-CV Activity Allocations to allocate \$5,960,899 of Emergency Solutions Grant-Coronavirus, 2nd tranche (ESG-CV2) to activities to prevent, prepare for, or respond to the Coronavirus among homeless populations and persons at risk of homelessness; and authorizing the City Manager or designee to sign all implementing documents as approved to form by the City Attorney
3. ***RESOLUTION - Adopting the 59th amendment to the Annual Appropriation Resolution No. 2020-159 appropriating \$3,796,000 for COVID-19-related CDBG activities (Requires 5 affirmative votes) (Subject to Mayor's veto)

A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, ADOPTING SUBSTANTIAL AMENDMENT 2019-06 TO THE 2019-2020 ANNUAL ACTION PLAN AND COVID-19 AMENDMENTS TO THE CITIZEN PARTICIPATION PLAN TO SUBMIT A REQUEST TO HUD TO PROGRAM \$7,980,086 OF COMMUNITY DEVELOPMENT BLOCK GRANT-CORONAVIRUS (CDBG-CV) FUNDS TO PREVENT, PREPARE FOR, AND RESPOND TO THE CORONAVIRUS (COVID-19); APPROVING ALLOCATIONS TO ACTIVITIES IN ACCORDANCE THEREWITH; AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO SIGN ALL IMPLEMENTING DOCUMENTS AS APPROVED TO FORM BY THE CITY ATTORNEY.

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires jurisdictions that receive federal entitlement program funds to prepare an Annual Action Plan, which identifies the projects to be funded with Community Development Block Grant (CDBG) Program funds; and

WHEREAS, on May 2, 2019, the Council of the City of Fresno adopted Resolution 2019-096, approving the City of Fresno (City) FY 2019-2020 Annual Action Plan; and

WHEREAS, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136, directed HUD to allocate additional entitlement funds to prevent, prepare for, and respond to the coronavirus (COVID-19); and

WHEREAS, HUD allocated CDBG-CV1 funds of \$4,184,132 and CDBG-CV3 funds of \$3,795,954 for a total of \$7,980,086 to the City to prevent, prepare for, and respond to the coronavirus (COVID-19); and

WHEREAS, HUD has issued a waiver allowing the City to amend its Citizen Participation Plan to conduct a 5-day public comment period and add provisions for

1. The above recitals are true and correct and incorporated herein.
2. The Council of the City of Fresno, California, approves submission of Substantial Amendment No. 2019-06 to the FY 2019-2020 Annual Action Plan and COVID-19 Amendments to the 2020-2024 Citizen Participation Plan to HUD;
3. The City Manager or designee is authorized to sign all reasonably required or implicated documents, instruments, and funding agreements in pursuit hereof, subject to prior approval as to form by the City Attorney's Office.
