WHEREAS, the City spends substantial funds, both general fund and from other sources, to provide services to the City's homeless population; and

WHEREAS, the Council seeks a comprehensive audit of homeless services funded by the City.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Council hereby directs the performance of an audit of homeless services funded by the City.

2. The City administration shall request assistance from Assemblymember Arambula in performing the audit.

3. The City's independent auditors (not City employees) shall provide to Council a written audit report and Council meeting discussion item within 90 days of this Resolution.
