BACKGROUND OF PROJECT (To be completed by Evaluating Department/Division. Explain need for project/equipment):

The design phase of this project was initiated in FY2019 when the City Council approved a list of projects to receive Senate Bill 1 (SB1) Road Maintenance and Rehabilitation Account funding. The funds were obligated and the project was budgeted in the Council-adopted FY2019 Capital Budget. The project was designed by Department of Public Works staff and took approximately 12 months to complete.

The scope of work for the Cedar Pavement Overlay includes a grind and overlay of Cedar Avenue, between Barstow and Bullard Avenues, as well as curb ramp reconstruction that complies with Americans with Disabilities Act (ADA) requirements and replacement of existing vehicle detection loops. Pavement striping will replace the existing travel lane configuration, including Class II bike lanes in both directions.

DEPARTMENT CONCLUSIONS AND RECOMMENDATION:

Award a contract in the amount of \$ 563,240.00 to Cal Valley Construction, Inc. of Fresno, CA as the lowest responsive and responsible bidder.
