A RESOLUTION OF THE COUNCIL OF THE CITY OF  
FRESNO, CALIFORNIA, TO AMEND THE COUNCIL  
RULES OF PROCEDURE.

WHEREAS, on May 9, 2013, Council adopted the Rules of Procedure of the City Council in Resolution No. 2013-65, to establish rules for the conduct of its proceedings; and

WHEREAS, Council has amended the Rules of Procedure from time to time to account for changes in practice or to clarify and conform to existing practice; and

WHEREAS, Council now wishes to amend certain of its Rules of Procedure in the interest of clarity and efficiency; and

WHEREAS, Council wishes to amend Rule No. 6 to require all supporting documents, including Powerpoints, be submitted by 5:00 Thursday before the meeting; and

WHEREAS, Council wishes to amend Rule No. 10 to allow public comment on contested consent items be heard at the time the contested item is heard, and to also require interpreters be chosen from the Judicial Council's Master List of Certified and Registered Court Interpreters; and

WHEREAS, the proposed change is in the interest of the Council's conduct of business of the City.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

SECTION 1. This resolution is adopted to amend the Rules of Procedure as set forth in Exhibit A.

SECTION 2. The procedures are in addition to, and not in place of, applicable ordinances and statutes. In the event of conflict between any part of this resolution and applicable ordinances and statutes, the latter shall govern.

SECTION 3. This resolution shall become effective and in full force upon final passage.
