Comments on Proposed Resolution to Amend Fresno General Plan Policy RC-9- c (Farmland Preservation Program) pursuant to Fresno Municipal code Section 15-5803

Dear Members of Fresno City Council:

While I am not a resident of the City of Fresno and am therefore not your constituent, I am a resident of the County of Fresno and am therefore impacted by your decision-making. I am a fifth generation citizen of Fresno County and have seen the negative impacts on the rural environment from the exponential growth of the county's population and the entire infrastructure needed to sustain that growth.

The driver of this resolution is money the city will receive through development fees connected to projects that will be enabled by the proposed amendment. I suspect also that wealthy developers will benefit from the amendment and that the proposed amendment is a result of their lobbying efforts.

When does it become obvious to all of us—including the city council and mayor—that continued growth of this sort is unsustainable and self-defeating?

Not only does such growth require covering valuable farm land with unsustainable residential and commercial development, but it requires more and more water from an ecosystem that simply doesn't have enough water to meet current needs, much less additional needs caused by more development and a larger population.

Our current economic system encourages us to grow and grow even though we are running out of space and resources to sustain such growth.

You may believe that as a mere city council member you have little control over such a large and powerful system as the US economy, but ultimately even an economy as powerful as the US economy is subject to the limitations of the environment that contains it.

Perhaps it is time for the city council to set a timely example and adopt a no-growth policy that considers the benefits of a steady-state economy that can exist within environmental limitations and enable the current population to live sufficiently. (Need I remind you, we have many people now in our midst who do not possess the means to live sufficiently?)

By continuing on the current unsustainable path, we are essentially stealing from our children and forcing them to live in a declining and ever more crowded environment. As Ed Abbey said, "Growth for growth's sake [or profit's sake for that matter] is the ideology of a cancer cell."
