A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING APPLICATION TO AND ACCEPTANCE OF FUNDING FROM THE STATE OF CALIFORNIA BUSINESS, CONSUMER SERVICES AND HOUSING AGENCY'S (BCSH) CALIFORNIA INTERAGENCY COUNCIL ON HOMELESSNESS (CAL ICH) AS AN INDIVIDUAL APPLICANT FOR THE FOURTH ROUND OF HOMELESS HOUSING, ASSISTANCE, AND PREVENTION PROGRAM (HHAP) AND AUTHORIZING THE CITY MANAGER TO SIGN ALL REQUIRED IMPLEMENTING DOCUMENTS TO APPROVE

WHEREAS, the City of Fresno (City) has been recognized as an eligible applicant to apply for HHAP program funds; and

WHEREAS, eligible applicants may apply as either Continuums of Care, as identified by the United States Department of Housing and Urban Development (HUD), large cities (with populations of 300,000 or more) or counties; and

WHEREAS, BCSH requires all eligible applicants to submit an Application and updated Local Homelessness Action Plan to Cal ICH and indicate whether they intend to apply for HHAP-4 funding jointly with an overlapping jurisdiction or as an individual entity; and

WHEREAS, the City desires to apply as an individual entity for the Homeless Housing, Assistance, and Prevention (HHAP) Program round 4 allocation.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:
