BACKGROUND OF PROJECT (To be completed by Evaluating Department/Division. Explain need for project/equipment):

The new Traffic Signal at Clinton and Thorne Avenues will assist pedestrians crossing Clinton Avenue. Clinton Avenue crossing at Thorne Avenue is currently unmonitored and designated a school route to access Hamilton Elementary School to the south. The installation of the signal will dedicate a traffic light to stop vehicles and allow pedestrians to cross Clinton Avenue with their own dedicated pedestrian phase. This will alleviate and reduce the current pedestrian conflicts at the intersection. The project includes installation of a new traffic signal with phasing for a dedicated pedestrian street crossing, new crosswalks, minor pavement repair, ADA-compliant curb ramps, signing and pavement striping.
