SUMMARY

The City of Fresno is an entitlement community receiving Community Development Block Grant (CDBG) funding from the U.S. Department of Housing and Urban Development (HUD). As an entitlement community the City is required to prepare an annual action plan detailing how funds received from HUD will be expended to meet housing and community development goals outlined in the Consolidated Plan.

The 2014-2015 Annual Action Plan was approved by the Fresno City Council on June 19, 2014. The City proposes to substantially amend the FY 2014-2015 Annual Action Plan to implement the following:

- 1. Neighborhood Infrastructure Program Reconstruct streets, sidewalks, and curb cuts in low moderate income areas. *CDBG \$1.4 million*.
- 2. Lead Hazard Control Program Establish a Lead Based Paint Program to abate lead hazards and to serve as a match to the federal lead hazard control program. *CDBG* \$150,000.
- 3. Homeless Services Planning and Administration Implement housing administration services for homeless persons. *CDBG \$57,400*.

Each program/project has been determined to be a new use of funds or differs from the projects originally adopted. The proposed changes are substantial and require a 30-day public review and comment period. Substantial Amendment No. 2015-002 will be made available for public review and comment **December 17, 2014 through January 15, 2015.**





Project:	Lead Hazard Control Program	
Grant:	Community Development Block Grant (CDBG)	
Award Amount:	\$150,000	
Description:	CDBG funding in the lead program will provide a portion of the required 25% match (\$593,750) and can be used for Staff cost for the administration, outreach, and remediation regarding eligible units enrolled in the program. Units must meet all Lead Hazard control Program eligibility requirements of having a house built prior to 1978 with hazardous lead, the presence of children under 6 years of age, and be income eligibility (80% AMI). More importantly CDBG funding will be used for a portion of the required 25% match for the lead program.	
Location of Activity:	The target area for the Lead Hazard Control encompasses four zip codes, 93727, 93701, 93702 and 93706. These zip codes have been determined to be areas with some of the highest incidents of elevated blood lead levels (EBLLs) for children in California, and they have the highest percentage of pre-1978 housing units. The City will focus outreach, education and door-to-door contact in these zip codes, but will make the program available city-wide for eligible families and homes.
