A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE SUBMISSION OF GRANT APPLICATIONS TO THE CALIFORNIA DEPARTMENT OF TRANSPORTATION'S ACTIVE TRANSPORTATION PROGRAM CYCLE 8 CALL FOR PROJECTS THAT SUPPORT ACTIVE TRANSPORTATION AND AUTHORIZING THE EXECUTION OF GRANT APPLICATIONS AND ACCEPTANCE OF GRANT FUNDS, AND EXECUTION OF GRANT AGREEMENT DOCUMENTS BY THE PUBLIC WORKS DIRECTOR OR DESIGNEE

WHEREAS, the City of Fresno is an eligible applicant of the 2026 Active Transportation Program (ATP) Cycle 8 grant program; and

WHEREAS, the ATP provides grant funding for eligible local agencies for the purpose of increasing the proportion of trips accomplished by biking and walking, increasing the safety and mobility of non-motorized users, advancing the active transportation efforts of regional agencies to achieve greenhouse gas reduction goals, enhancing public health, ensuring disadvantaged communities fully share in the benefits of the program, and providing a broad spectrum of projects to benefit many types of active transportation users; and

WHEREAS, the California Transportation Commission, California Department of Transportation, and Fresno Council of Governments administer the program and have requested applications from eligible agencies;

WHEREAS, the Department of Public Works intends to submit grant applications for funding of the projects to support active transportation;
