A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO MAKING THE SECOND AMENDMENT TO RESOLUTION NO. 2025-177 ENTITLED "A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO ESTABLISHING RULES FOR THE APPLICATION OF CITY EMPLOYEE COMPENSATION RATES AND SCHEDULES AND RELATED REQUIREMENTS, AND ESTABLISHING COMPENSATION RATES AND SCHEDULES FOR FISCAL YEARS 2026 AND 2027"

Exhibit 14, Unit 14, Management Classes (CFMEA), is hereby amended to provide salary increases for respective classes as required by the adoption of the successor Memorandum of Understanding between the City and City of Fresno Management Employees Association (Management Classes – Unit 14), effective June 15, 2026.

SECTION 4.

Exhibit 14, Unit 14, Management Classes (CFMEA), is hereby amended to provide salary increases for respective classes as required by the adoption of the successor Memorandum of Understanding between the City and City of Fresno

Management Employees Association (Management Classes – Unit 14), effective December 28, 2026, if either contingencies are met.

SECTION 5.

Upon final legislative approval, this Resolution shall become effective July 28, 2025.
