The Engineer's Estimate for this expenditure is \$371,629.75. The contract price is 16.79% above the Engineer's Estimate. If the overage is greater than 10% or only one bid was received, give explanation:

The bid results indicate the one bidder as the sole responsive bid received. The bid evaluation results highlighted that bid items involving purchase of larger quantities of construction material or higher cost items were approximately 1.5-2 times higher than the Engineer's Estimate. Bid items involving a service and/or small construction material quantities were typically priced comparable to the Engineer's Estimate. Majority of overage is due to bid results for bid item "Grading (Finish)," being approximately 10 times higher and "Miscellaneous Facilities and Operations," being approximately 5 times higher than the Engineer's Estimate.

<u>BACKGROUND OF PROJEC</u>T (To be completed by Evaluating Department/Division. Explain need for project/equipment):

The California Tupman Park Improvements at Cesar Chavez Boulevard and Tupman Avenue, and the Romain Park Improvements at Thomas Avenue and First Street, will provide accessibility, irrigation, landscape, and play structure area improvements enhancing park guest experience, safety and accessibility at each location.

The project specific scope for California Tupman Park includes the replacement of three picnic tables with one meeting ADA requirements, temporary Measure P signage, and the installation of a shade structure over the existing merry-go-round and swing set.

The project specific scope for Romain Park includes ADA compliant deepened concrete playground curb and concrete edge, Measure P signage, and the installation of two waste receptables on concrete pads along the path of travel. Additionally, the existing mulch surfacing will be replaced with pour-in-place soft-fall safety surfacing.
